## **Non-Discrimination Requirements**

#### **USDA Non-discrimination Statement**

### **How to file a USDA Program Discrimination Complaint**

To file a complaint alleging discrimination, complete the USDA Program Discrimination Complaint Form, AD-3027, found online at <a href="https://www.ascr.usda.gov/filing-program-discrimination-complaint-usda-customer">https://www.ascr.usda.gov/filing-program-discrimination-complaint-usda-customer</a> or at any USDA office or write a letter addressed to USDA and provide in the letter all of the information requested in the form. #### Purpose and Content of the "And Justice For All' Poster:
